Overview:

Mr. Kelly will provide the City of Manning assistance with the Comprehensive Planning process for 2016. Mr. Kelly stated that the Comprehensive Plan was adopted in 1994 by the state of South Carolina and a Comprehensive Plan is required by law for governing agencies that provides land use and zoning. The Comprehensive Plan review is conducted every 10 years and re-evaluated every 5 years. The plan can be amended at any given time. Those involved in the Comprehensive Plan process includes but not limited to, the Planning Commission, City Council, the public, and the community. The Planning Commission recommends the plan to City Council and City Council either adopts or denies the Comprehensive Plan proposed.

Resources available when analyzing the Comprehensive Plan:

The City of Manning must consider the budget to identify available funds when analyzing the Comprehensive Plan as well as other available resources.

Process:

- Inventory Current Conditions: Existence of the City of Manning as of 2016
- Needs and Goals: Long and short term goals
- Identify Implantation Strategies with Time Frame: Time frame for action

9 Required elements of the Comprehensive Plan:

- Population: Demographics, historic trends, etc.
- Economic Development: Community income, employment rate and residential status
- Natural Resources: Wet lands and flood plains, agricultural land, recreational, etc.
- Cultural Resources: Historical sites
- Community Facilities: Libraries, Fire Departments, Police Departments, etc.
- Housing: Single family homes, duplexes, apartment complexes, etc.
- Land Use: Zoning and rezoning areas
- Transportation: Roadways repair, bicycle lanes, pedestrian lanes, etc.
- Priority Investment: Federal, State and Local funds available
- (Optional) Surveying and Input Collection: View on growth
