ITEM 3: IF AN ORGANIZATION NAME WAS PROVIDED IN ITEM 1 ENTER THE ORGANIZATION'S REPRESENTATIVE NAME HERE.

ITEM 4: ENTER THE DATE(S) OF THE SALE. MAXIMUM 2 DAYS PER YEAR.

ITEM 5: ENTER THE LOCATION WHERE THE SALE WILL BE HELD.

ITEM 6: IF SALE IS BEING HELD AT APPLICANT'S PROPERTY CHECK YES, IF SALE IS BEING HELD AT LOCATION OTHER THAT APPLICANT'S PROPERTY CHECK NO.
